Explanation of Responses:

- Restricted stock subject to a vesting schedule. The restricted stock grant was made by the Board of Directors of Hub Group, Inc. on January 2, 2014.
- Since the date of Mr. Ward's last ownership report, he transferred to his ex-wife pursuant to a domestic relations order: (i) 1,006 shares of fully vested Class A Common Stock, (ii) 1,667 unvested shares of Class A Common Stock (with half of such unvested shares vesting on January 2, 2014 and half scheduled to vest on January 2, 2015) and (iii) 100% of Mr. Ward's restricted stock unit award granted on January 2, 2013. Mr. Ward no longer reports as beneficially owned any shares or restricted stock units owned by his ex-wife.
- Disposition of shares to satisfy withholding tax obligations with respect to 833 shares on which restrictions lapsed as of 1/2/2014.
- 5,833 of the shares of Class A Common Stock are restricted stock subject to vesting requirements.
